**Strathay Road, Perth.
(From Garth Avenue Junction to Fortingall Place Junction).
Carriageway Resurfacing Works.**

The Council intends to carry out carriageway resurfacing work on the above section of road. The work is due to start on Monday 02 December 2019 and is expected to take just over a week to complete.

During the works the road will be closed to through traffic with access only for residents who stay within the road closure. However depending on where the work is being carried out, residents might be delayed gaining access to their properties by car or might need to take access from the other end of the works. Pedestrian access should be relatively unaffected.

Parking will be suspended throughout the length of the surfacing works and I would ask that any vehicles parked at this location are moved prior to the works starting on Monday 02 December before 7:30am so the work can proceed.

Parking will also be suspended on Garth Avenue (from Strathay Road to Struan Road) and Fortingall Place (from Garth Avenue to Strathay Road) to assist with the free flow of diverted traffic during the works. I would ask that any vehicles parked at these locations are moved prior to the works starting on Monday 02 December before 7:30am.

To comply with Health & Safety legislation there will be pedestrian barriers placed along the front of the footways to prevent the public from crossing into the works when resurfacing the road.

I would like to take this opportunity to apologise for any inconvenience caused by the works and to thank you in advance for your co-operation.

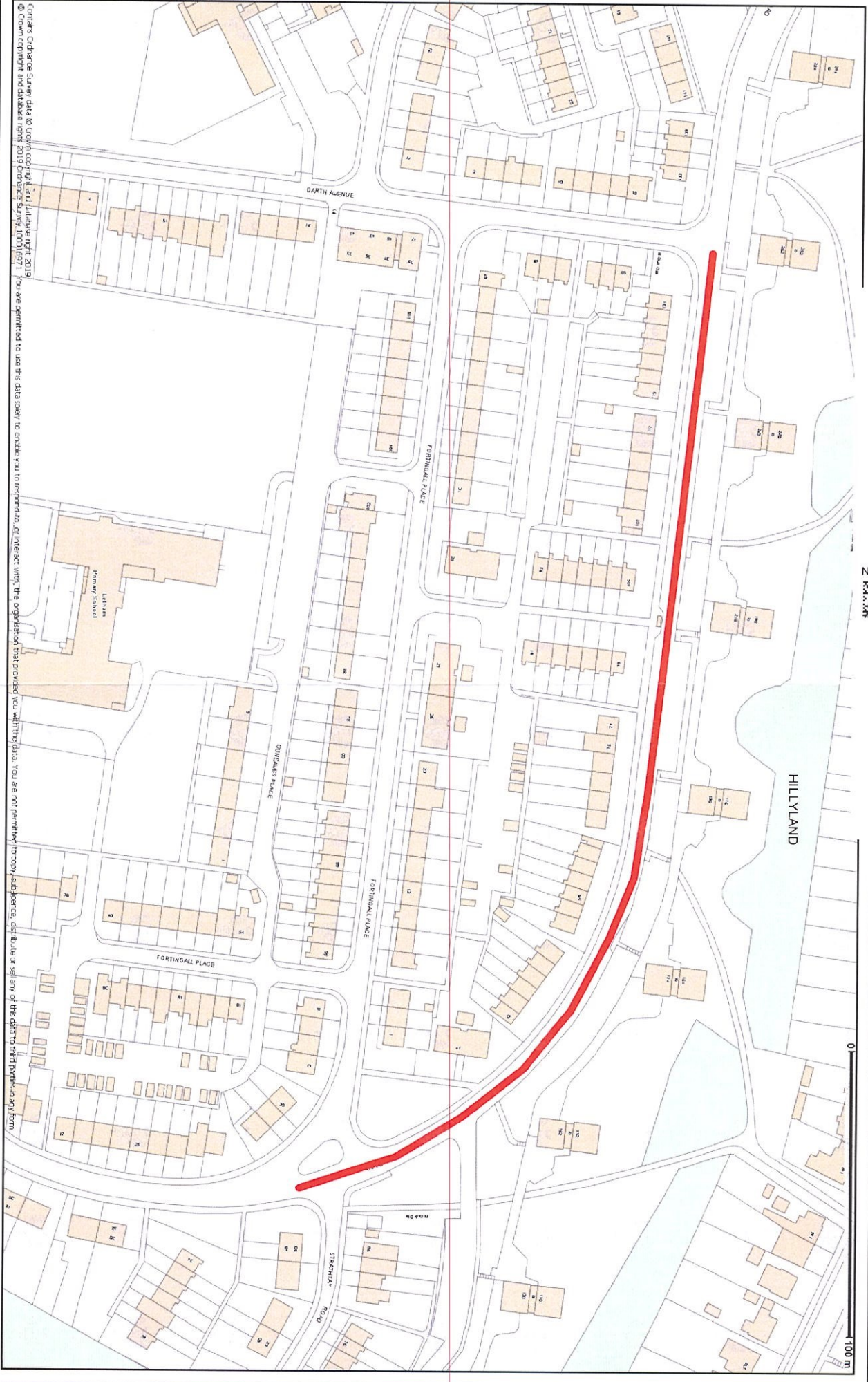
