Lornshill Academy Cost of the School Day

In January 2018 End Child Poverty published figures estimating that one in four children in Scotland were living in poverty, Clackmannanshire mirrors this trend. Lornshill Academy is committed to ensuring all our pupils have equal opportunity to succeed at school, regardless of their financial situation. Therefore it is important we understand all the costs associated with children attending school on a daily basis. School costs which are difficult to meet can mean young people miss out on the full range of opportunities available to them. Poverty can lead to young people feeling excluded or embarrassed which makes it difficult for young people to learn, to achieve and to be happy at school.

We used the Cost of the School Day Toolkit, developed by Child Poverty Action group, to help us identify and overcome any barriers that children may face in terms of the costs associated with participation and engagement at school. In Lornshill Academy our consultation involved pupils, parents and staff who completed questionnaires and participated in focus groups.

Findings of Consultation

The consultation highlighted many areas where Lornshill Academy policies and strategies were successful in mitigating the potential impact of poverty. These included:

- Simplified, unbranded uniform which allows parents to buy uniform from any supplier.
- Finger print payment for all meals non stigma for pupils receiving FSM.
- School Trips and other costs can be paid in instalments to ensure affordability.
- Breakfast club which is staffed and free to pupils.
- Equipment is available for pupils use, including PE kit and ICT resources.

However, as we constantly strive to improve, four areas were identified and will be the focus of our COTSD Action Plan.

- 1) Uniform
- 2) Learning at School
- 3) Eating in School
- 4) School Trips
